At its meeting on June 10, 2021, the State Executive Council for Children's Services (SEC) approved the initial step in a proposed intent to develop policy for the following two (2) policies:

- SEC Policy 3.2 – Family Assessment and Planning Team
- SEC Policy 3.3 – Family Engagement

This is the first step (Notice Stage) in the process as described under SEC Policy 2.4. After this initial period, the SEC will determine whether to move forward with specific policy proposals and additional public comment will be sought.
