



## Summary of Executive Orders 53 & 55

Executive Order 53 bans all public gatherings of more than 10 people, closes schools, closes recreational and entertainment businesses, and further regulates some non-essential retail businesses such as restaurants, dining establishments, etc. Non-essential retail businesses must limit their operations to ten patrons or less with adequate social distancing. If they cannot limit their operations to 10 patrons or less with adequate social distancing, then they must close.

Executive Order 55, instructs all Virginians to stay at home until June 10, 2020. The Order closes all public beaches, in-person classes at institutions of higher education, and overnight stays at private campgrounds of less than 14 nights.

### Steps To Slow The Spread of COVID 19

COVID-19 is a respiratory illness that can spread from person to person.

Residents are encouraged to follow these instructions to prevent disease spreading to people in your home and community.

SYMPTOMS can include FEVER (measured at 100.4°F/38°C or higher/ or if you feel feverish), COUGH or TROUBLE BREATHING. Illnesses have ranged from mild symptoms to severe illness and death. Symptoms may appear 2–14 days after exposure. Not everyone needs to be tested for COVID-19. Most people will have mild illness and be able to recover at home.\*

(\*Older adults and people of any age with serious underlying medical conditions may be at higher risk for more serious disease. Seek care early.)

## IMPORTANT INFORMATION ABOUT COVID-19

From Crater District Health Departments

### If You're Sick and Have Symptoms:

1. Stay home. Avoid contact with others, do not share personal items, and use a separate bedroom and bathroom, if possible.
2. Monitor your health. Seek medical attention immediately if you develop trouble breathing, pain or pressure in the chest, confusion, or bluish lips or face. Call ahead.
3. Wear a face mask (or a bandana or scarf that covers your nose and mouth) when around other people.
4. Cover your coughs and sneezes with a tissue or the inside of your elbow.
5. Wash your hands often with soap and warm water for at least 20 seconds.
6. Clean and disinfect high-touch surfaces every day.
7. Do not leave home until fever-free for 72 hours (without the help of medication) AND your other symptoms have improved AND at least 7 days have passed since symptoms first appeared.
8. Inform close contacts. Talk to everyone who has been within 6 feet for more than a few minutes while you were sick, including the 48 hours BEFORE you developed symptoms. Tell them to stay home for 14 days.

### If You Had Close Contact With Someone Who Is Sick:

1. Stay home for 14 days since you last interacted with the ill individual. If you have ongoing exposure (for example you live with the person who is sick), stay home while the person is sick and for 14 days after the person has been released from isolation. Avoid contact with others even though you may feel well. Do not share personal items, and use a separate bedroom and bathroom, if possible.
2. Wear a face mask (or a bandana or scarf that covers your nose and mouth when around other people.
3. Monitor for symptoms. Take your temperature with a thermometer two times a day and watch for fever or cough.
4. Keep your distance from others (at least 6 feet).
5. Cover your coughs and sneezes with a tissue or the inside of your elbow.
6. Wash your hands often with soap and warm water for at least 20 seconds.
7. Clean and disinfect high-touch surfaces every day.
8. If you become sick, stay home, keep your distance from others, and inform close contacts you are sick. Follow the guidance under "if you are sick and have symptoms."
9. Inform close contacts. Talk to everyone who has been within 6 feet for more than a few minutes while you were sick, including the 48 hours BEFORE you developed symptoms. Tell them to stay home for 14 days.

# How To Identify and Talk To Your Close Contacts About COVID-19

If you have symptoms of COVID-19, it is important that you alert everyone who has been within 6 feet for more than a few minutes while you were sick. The steps below will help you identify and talk to your close contacts.

1. Document day, date, time your symptoms began: \_\_\_\_\_ (day) \_\_\_\_\_ (date)

## How To Inform Your Close Contacts

Call your contacts and tell them you are sick. By sharing your information with others, you can slow the spread of illness.

Example: “Hi. I am sick with symptoms of COVID-19 (the coronavirus infection). I’m calling you because when we met you may have been exposed. Most people who get sick are able to recover at home. The Health Department recommends that you do the following:”

- Stay home for 14 days since you last interacted with the ill individual. If you have ongoing exposure (for example if you live with the person who is sick), stay home while the person is sick and for 14 days after the person has been released from isolation. Avoid contact with others, do not share personal items, and use a separate bedroom and bathroom, if possible.
- Monitor for symptoms. Take your temperature with a thermometer two times a day and watch for fever (measured at 100.4°F/38°C or higher/ or if you feel feverish) or cough. Seek medical attention immediately if you develop trouble breathing, pain or pressure in the chest, confusion, or bluish lips or face. Call ahead.
- Keep your distance from others (at least 6 feet).
- Cover your coughs and sneezes with a tissue or the inside of your elbow.
- Wash your hands often with soap and warm water for at least 20 seconds.
- Clean and disinfect high-touch surfaces every day.
- If you become sick, stay home and keep your distance from others.
- Inform others if you become sick. Talk to everyone who has been within 6 feet for more than a few minutes while you were sick, including the 48 hours BEFORE you developed symptoms. Tell them to stay home for 14 days. If you get sick, call your doctor or healthcare provider and let them know you were exposed to someone with COVID-19 and now are ill.

## Broadband Update

With many Dinwiddie citizens now working and learning from home, expanding broadband Internet coverage is more important than ever. The Dinwiddie County Board of Supervisors approved RiverStreet Networks' first Coverage, Phasing and Implementation Plan on March 17, 2020. The first phase of this plan aims to expand wireless Internet service from the following four sites in Dinwiddie County: the Town of McKenney water tower, the Dinwiddie County Landfill tower on Wheelers Pond Road, a sub-carrier tower near Darvills, and the Old Northside Elementary School site on Cox Road. Coverage, pending final Board approval, is expected to be offered from the McKenney and Landfill sites in Fall 2020; and the Darvills and Old Northside Elementary sites by Spring 2021.



Phase two will aim to expand Internet service to areas of northern Dinwiddie County from Lake Chesdin west along Route 460 by the first quarter of 2022. Phase three will expand Internet coverage to other unserved areas of Dinwiddie County by the end of 2022.

## Dinwiddie County Expands Public WiFi

In an effort to accommodate Internet needs of Dinwiddie County citizens during this public health emergency, the Department of Information Technology has expanded Guest WiFi service at key public facilities. Beginning immediately, citizens may access the County's Guest WiFi in parking lots of the following facilities:

### Dinwiddie County Government Center | Eastside Community Enhancement Center | McKenney Gym | Robert & Betty Ragsdale Community Center

Please note the following: This expanded WiFi is NOT intended to encourage carpooling. Citizens are advised to ONLY transport individuals residing in the same household. *If you've been together - stay together.*

- Patrons are encouraged to continue to follow social distancing guidelines when visiting these sites.
- Patrons MUST remain inside their vehicles at all times.
- Facilities remain CLOSED to the public.
- NO public restrooms are available.
- The speed of Guest WiFi is affected by the number of users at any given time. Please be considerate of your neighbors by limiting each WiFi session to one-hour.
- Patrons are using the County's Guest WiFi of their own volition. Dinwiddie County is not responsible for personal devices and cannot provide technical assistance.
- Dinwiddie County WiFi expansion sites are under video surveillance and will be subject to periodic patrols by the Dinwiddie County Sheriff's Office.

# OPERATIONAL CHANGES DUE TO COVID-19

## County Administration

County Administration staff is available by phone at: 804-469-4500, option 8, during normal business hours.

In an effort to maintain transparency of government, the Board of Supervisors has adopted remote meeting procedures. These procedures allow for board or commission members, staff, and citizens to participate in public meetings remotely. ## Commissioner Of The Revenue

The Commissioner of the Revenue and her staff are working tirelessly to continue to provide the level of customer service to which Dinwiddie County citizens have come to expect. In an effort to protect the health and safety of staff and citizens, staff are working staggered shifts. Correspondence may be delivered by mail or by using the Treasurer's drive-through drop-box, located in the traffic loop of the Government Center (facing the Courthouse). The office is available by phone at: 804-469-4500, option 4, during normal business hours.

## Sheriff's Office

The Sheriff's Office continues to provide uninterrupted service to the citizens of Dinwiddie County. To help protect the safety of our deputies and staff, temperatures are taken at the beginning of each shift. Arrestees are immediately screened and provided with personal protective equipment. As our building remains open to the public, patrons are screened as they enter the lobby of the Public Safety Building.

## Circuit Court Clerk's Office

During the COVID-19 pandemic, the Circuit Court Clerk's Office will be open to the public from 8:30 am to 12:30 pm, with limited staff. Hours are subject change as the pandemic evolves. Citizens are encouraged to transact business with our office by mail, phone, email, or online. Please avoid coming into the office if at all possible. All non-emergency court cases scheduled during this time will be continued. We appreciate your patience as we strive to continue to provide the best customer service possible, while protecting the health of our staff and the public. ## Treasurer's Office

The Treasurer's Office is providing options to accommodate payment of taxes that have not been provided in the past. Options will be outlined on a pink insert with your bill. Please note, credit and debit cards will not be charged fees at this time for online transactions as well as payments placed in the drop box. To protect the health and safety of our employees and citizens, Treasurer's Office staff are working from alternative locations, and in staggered shifts, as we continue to provide optimal customer service to taxpayers.

## General District Court

Due to the coronavirus outbreak there has been an Order issued from the Supreme Court of Virginia ordering only certain cases to be heard by this court. The General District Court will by handling only lock up arraignments, emergency motions and protective orders until further notice. Payments to the General District Court may also be made through this website.

If you have been summonsed to appear in the Dinwiddie Juvenile and Domestic Relations District Court and have not received notice of a new court date, you must contact the Clerk's Office at 804-469-4533, ext. 5113 for the status of the case.

## Finance Department

We are continuing to provide financial support services for County operations through electronic communications with both vendors and employees. Procurement opportunities can be found on the County's website, and we would appreciate all vendors submitting invoices to [accounting@dinwiddieva.us](mailto:accounting@dinwiddieva.us) rather than mailing in hard copies. We are also revising our FY 21 budget to reflect the changing economy. A public hearing on the FY 21 budget will be held on April 21, 2020, with budget adoption taking place at the May 5th Board of Supervisors meeting. ## County Attorney

The County Attorney's Office continues to provide legal advice vital to the operation of Dinwiddie County government, including the response to COVID-19. ## Economic Development

Dinwiddie County is proud of our essential retail businesses that are continuing to serve our community's needs during the COVID-19 pandemic such as our grocery, dollar, convenience, hardware, and feed stores as well as our restaurants that have adjusted to carry out, curbside pickup, and delivery. The daycare businesses in the community have also continued to be operational and serve the childcare needs of families of essential workers, and most importantly to serve our healthcare workers and first responders during this time.

COVID-19 is a global crisis that has disrupted our community, especially our Business community. Information and resources continue to evolve and are updated daily. ## Waste Management

In a continued effort to allow our most vulnerable employees to stay at home during this COVID-19 public health crisis, Dinwiddie County implemented operational changes to public works. These changes were effective March 19, 2020:

- Manned convenience sites will ONLY accept household trash.
- Metal and large items, including furniture, MUST be taken to the landfill.
- Brush will ONLY be accepted at the landfill.
- Anyone arriving at a manned site with brush, metal or large items, including furniture will be redirected to the landfill.
- Manned convenience centers in Old Hickory and Wilsons will be CLOSED on Wednesdays.

Citizens are encouraged to continue adherence to social distancing guidelines when visiting manned sites and the landfill, and remain INSIDE their vehicle while the attendant operates the trash compactor. Despite limited staffing, we continue to experience an increase volume of trash at manned sites and appreciate your continued patience and cooperation.

## Building Inspections, Planning, Zoning, Code Compliance and Environmental Services

Staff are available by phone: 804-469-4500, option 6 during normal business hours.

The County is committed to continuing service to our citizens and businesses during this national pandemic. All correspondence will be conducted by phone, email or U.S. Mail. A drop box is available at the building entrance for documents (plans, applications, permits, etc.). Items left in the drop box will be reviewed and any questions handled by phone. Documents will be returned by email or U.S. Mail after processing. During the COVID-19 response, enforcement actions will be prioritized based on community health, safety, and welfare.

## Emergency Communications, Fire & EMS

Emergency Communications, Fire & EMS continue to provide uninterrupted service during this public health emergency. In an effort to gather as much information as possible, and to protect first-responders and citizens, anyone calling 911 with an emergency will undergo COVID-19 screening. This includes a series of questions regarding travel, potential exposure, outstanding orders of isolation/quarantine, and symptoms of the virus. Please be patient and cooperative as these additional questions are essential to providing the best response possible to your emergency. Callers will be asked to meet first-responders outside of the home, if possible, and those on scene will be provided and required to wear masks during the interaction with first-responders. Please be advised that first-responders will arrive wearing full personal protective equipment (PPE) and will remain as such for the duration of the interaction.

We appreciate your continued support and cooperation during this unprecedented event. Rest assured that our first-responders are well-trained and fully prepared to deliver optimal service, despite these extenuating circumstances.



## Human Resources

Human Resources remains fully committed to supporting the needs of our workforce during this challenging time. The department is working behind the scenes to ensure employees in the most high risk category have been removed from working the frontlines. The department is honored to support the Dinwiddie County workforce as we work through this uniquely challenging time.

## Parks & Recreation

At this time, all Parks and Recreation facilities, programs and activities have been cancelled until June 10, 2020.

## Department Of Social Services

While the Dinwiddie Department of Social Services remains closed to the public, our services continue. Staff are working remotely, as they are able, and staggering shifts in the office. We are accessible by phone during normal business hours: 804-469-4524.

In light of the COVID-19 pandemic, all Medicaid & FAMIS co-pays have been eliminated.

Medicaid is allowing members to fill a 90-day supply of many routine prescriptions. Check with your pharmacist or doctor.

In an effort to maintain health insurance coverage during the COVID-19 pandemic, Virginia Medicaid will not cancel coverage for eligible individuals, even if you are currently out of state.

VA Medicaid has issued guidance to providers allowing the following Medicaid services to be offered through telehealth and by telephone: care coordination, case management, peer services, needs assessments, and psychiatric services, including medication management and individual, group and family therapy. Medicaid recipients should contact their provider for additional information.

## 2020 CENSUS

Once every ten years, America comes together to count every resident in the United States. The first decennial census took place in 1790, as mandated by the Constitution. The Census counts our population and households, providing the basis for reapportioning congressional seats, redistricting, and distributing more than \$675 billion in federal funds annually to support states, counties and communities' vital programs – impacting housing, education, transportation, employment, health care and public policy.

The 2020 United States Census will be the twenty-fourth of its kind. By now, all homes in America should have received their questionnaire. This is the US Census to offer options to respond online, or by phone in addition to the traditional mail-in option. In May, 2020 the Census Bureau will begin visiting homes that have not yet responded to the survey and in December 2020, Census findings will be reported to Congress.



Dinwiddie County relies on census data in a variety of ways. Census data provides information on the County's population, demographics, education levels, and household income. It tells us the percentage of our population that has served or serves in the military, employment status and length of time spent commuting to and from work. This information is useful when applying for grant funds, courting prospective businesses, and recruiting for employment. Our finance department uses Census data, specifically population, when comparing Dinwiddie County to similar localities' revenue, expenditures and services provided to citizens, to ensure that we are operating within industry standards. Census data is extremely important and is only collected every ten years. We encourage all Dinwiddie County citizens to take a few minutes and complete the Census questionnaire. If our data is accurate, we will fare better over the next ten years. In Dinwiddie, EVERYONE counts!


