Mr. Massengill discussed the proposed FY 06/07 Budget. His discussion included the difference between the published budget and the proposed budget now before the Board. On the revenue side, the personal property tax revenue has been revised to reflect the most current NADA values from the Commissioner of Revenue’s office. The published proposed budget did not include the health insurance premium increase because it had not been finalized at time of

publishing. It also did not include the increase in purchased jail beds costs. Recommendations were discussed concerning the allocation of additional General Fund balance – 25% of new revenue transferred to debt service and the cash purchase of C.I.P. items that were previously going to be financed.

There was discussion regarding Dinwiddie Volunteer Rescue Squad. By consensus it was decided to reinstate \$10,000 in the budget for DVRS at a later time, after receipt of current income statement and balance sheet from them. There was also discussion regarding the color and striping of the new County fire truck. By consensus it was decided that it would be painted in the County colors.
