This being the time and place as advertised in the Progress-Index on January 6, 1996, for the Board of Supervisors to conduct a public hearing on the proposed establishment of the South Central Wastewater Authority (the "Authority"), pursuant to the Virginia Water and Sewer Authorities Act, Chapter 28, Title 15.1 of the Code of Virginia, as amended.

Mr. Charles W. Burgess, Jr., County Administrator, stated that the proposed Authority will own and operate certain wastewater treatment and related facilities currently owned by the City of Petersburg and situated on Pocahontas Island. The City of Petersburg, the City of Colonial Heights, Chesterfield County, Dinwiddie County and Prince George County shall jointly establish the Authority and the Authority shall provide sewage treatment services to each of the establishing jurisdictions.

Mr. William J. Leary, Director of Public Utilities for the City of Petersburg, came before the Board and gave a short overview on the Authority and how it will be structured.

Mr. John Clements, Chairman Dinwiddie County Water Authority, came before the Board and thanked them for their strong support during the planning stage of the project. CONCURRENT RESOLUTION OF THE CITY COUNCILS OF THE CITIES
OF PETERSBURG, VIRGINIA AND COLONIAL HEIGHTS, VIRGINIA AND OF
THE BOARDS OF SUPERVISORS OF CHESTERFIELD, DINWIDDIE AND PRINCE
GEORGE COUNTIES, VIRGINIA CREATING A SEWER AUTHORITY UNDER THE VIRGINIA
WATER AND SEWER AUTHORITIES ACT AND SETTING FORTH THE ARTICLES OF
INCORPORATION OF THE AUTHORITY

WHEREAS, the City Councils of the Cities of Petersburg, Virginia and Colonial Heights, Virginia and the Boards of Supervisors of Chesterfield, Dinwiddie and Prince George Counties, Virginia (each a "Governing Body" and collectively, the "Governing Bodies"), after notice and public hearing, have determined that creation of a Sewer Authority pursuant to the Virginia Water and Sewer Authorities Act, Chapter 28, Title 15.1 of the Code of Virginia, as amended, (the "Act") to own and operate certain wastewater treatment and related facilities would serve the interests of their citizens; and

WHEREAS, the Governing Bodies wish to create such an Authority as provided by the Act;

NOW, THEREFORE, BE IT RESOLVED by the City Councils of the Cities of Petersburg and Colonial Heights, and by the Boards of Supervisors of Chesterfield, Dinwiddie and Prince George Counties, in separate meetings assembled:

# Section 1

The Governing Bodies shall cause a joint application to be filed with the State Corporation Commission to create a Sewer Authority pursuant to the Act, to be known as the South Central Wastewater Authority (the "Authority").

#### Section 2

The purpose for which the Authority is formed is to acquire, finance, construct, expand, improve, operate and maintain wastewater treatment and related facilities (including, without limitation, sewerage trunk or interceptor lines and pumping stations, together with all appurtenant equipment necessary or suitable therefore and all properties, rights easements or franchises relating thereto and deemed necessary or convenient by the Authority for their operation) for the long-range needs of the Cities of Petersburg and Colonial Heights, and for Chesterfield, Dinwiddie and Prince George Counties.

The Authority shall be solely responsible for the operation and maintenance of such wastewater treatment and related facilities and for compliance with all requirements of applicable laws and regulations, except as otherwise provided in the Service Agreement to be entered into following creation of the Authority.

The Authority shall impose equitable charges against the jurisdictions in amounts necessary to amortize the costs of improving, expanding and providing for debt service of such improvements and expansions, in addition to charges for the maintenance and operation of the facilities, and the Authority shall impose charges on other users of its facilities consistent with existing contractual obligations and, otherwise, as it may deem appropriate.

Except as expressly limited herein and in the Articles of Incorporation, it is the intent of the Governing Bodies that the Authority have all of the powers granted to water and sewer authorities under the Act.

#### Section 3

The Articles of Incorporation of the Authority shall be as follows:

# ARTICLES OF INCORPORATION OF THE SOUTH CENTRAL WASTEWATER AUTHORITY

The City Councils of the Cities of Petersburg, Virginia and Colonial Heights, Virginia, and the Boards of Supervisors of Chesterfield, Dinwiddie and Prince George Counties, Virginia (each a "Governing Body" and collectively, the "Governing Bodies") desire to create an Authority pursuant to the Virginia Water and Sewer Authorities Act, Chapter 28, Title 15.1 of the Code of Virginia, 1950 as amended (the "Act"), which Authority shall be a public body, politic and corporate. The Governing Bodies hereby certify:

- 1. The name of the Authority shall be The South Central Wastewater Authority ("Authority").
- 2. The address of the principal office of the Authority shall be 900 Magazine Road, Petersburg, VA 23803.
- 3. The political subdivisions incorporating the Authority are the Cities of Petersburg and Colonial Heights, Virginia, and the Counties of Chesterfield, Dinwiddie and Prince George, Virginia ("Incorporating Subdivisions").
- 4. The purpose for which the Authority is formed is to acquire, finance, construct, expand, improve, operate and maintain wastewater treatment and related facilities (including, without limitation, sewerage trunk or interceptor lines and pumping stations, together with all appurtenant equipment necessary or suitable therefore and all properties, rights, easements or franchises relating thereto and deemed necessary or convenient by the Authority for their operation) for the long-range needs of the Incorporating Subdivisions.
- 5. The powers of the Authority shall be exercised by a board (the "Board") consisting of five members, one member to be appointed by each of the Governing Bodies.
- 6. The names, addresses and terms of the initial members of the Board are as follows:

The terms of the initial members of the Board shall begin on the date of the issuance of a certificate of incorporation by the State Corporation Commission and expire on the date set opposite his or her name; provided, however, that each initial member shall continue in office until he or she is reappointed or until his or her successor shall be duly appointed and qualified.

The successor of each initial member shall be appointed by the respective Governing Body that appointed the outgoing member, for a term

- of four (4) years but shall continue in office until his or her successor shall be duly appointed and qualified, except that any person appointed to fill a vacancy shall serve for the unexpired term. Any member shall be eligible for reappointment to the Board. Alternate members may be provided for in the Bylaws.
- 7. Each member of the Board shall be entitled to one vote on matters before the Board. A majority of members of the Board shall constitute a quorum.
- 8. Each member of the Board shall receive such compensation for his or her services as a member of the Board as may be provided from time to time by concurrent resolutions duly adopted by the Governing Bodies of the Incorporating Subdivisions. Each member shall be reimbursed for his or her actual expenditures necessarily incurred in the performance of his or her duties as a member of the Board.
- 9. The Governing Bodies of the Incorporating Subdivisions hereby find that it is impracticable to include herein estimates of capital costs, descriptions of specific projects to be undertaken or preliminary estimates of initial rates for services.
- 10. The Authority may contract with the Incorporating Subdivisions and any other political subdivision, any sanitary district thereof or any other authority created pursuant to the Act to furnish wastewater disposal services upon such terms and for such charges as the Authority shall determine, provided, however, that the service charges applicable to the Incorporating Subdivisions shall be uniform.
- 11. The Authority shall cause an annual audit of its books and accounts to be made by an independent certified public accountant at the end of each fiscal year, beginning with the fiscal year ending June 30, 1996. The Authority shall cause a copy of the annual audit to be delivered, upon completion, to the City Managers of Petersburg and Colonial Heights and to the County Administrators of Chesterfield, Dinwiddie and Prince George Counties.
- 12. The services provided by the Authority are limited to the provision of the services contemplated by Section 4.
- 13. Except as otherwise required by law, the Authority shall not undertake a project not underway or planned at the time of creation of the Authority within the boundaries of an Incorporating Subdivision without the consent of its Governing Body. Unless otherwise provided by the Board of Supervisors of Chesterfield County, the Authority shall serve only the Ettrick and Matoaca areas of Chesterfield County.
- 14. Except as may be expressly stated herein, nothing herein shall be construed as a limitation on the exercise by the Authority of the full powers granted to such entities under the Act.

The City Managers of Petersburg and Colonial Heights and the County Administrators of Dinwiddie, Chesterfield, and Prince George Counties are hereby authorized and directed to cause the executed Articles of Incorporation to be filed with proof of publication of the notices of public hearings and a record thereof which shall indicate whether the City Councils and the Boards of Supervisors desire to proceed with creation of an authority and whether any of the Governing Bodies called for a referendum pursuant to Section 15.1-1244 of the Act.
