A TARPULIN OVER AN OPEN BODY TRUCK SHALL NOT BE PERMITTED FOR THE COLLECTING OF REFUSE. (B) THE VEHICLE SHALL BE EQUIPPED WITH A FIRE EXTINGUISHER CAPABLE OF EXTINGUISHING CLASS A AND CLASS B FIRES. (C) IDENTIFYING INFORMATION ABOUT THE REFUSE COLLECTOR, SUCH AS NAME, ADDRESS, AND TELEPHONE NUMBER, SHALL BE DISPLAYED ON EACH VEHICLE. (D) THE VEHICLE SHALL BE KEPT IN A CLEAN AND SANITARY CONDITION.

<b>UPON ISSUANCE OF THE COUNTY REFUSE COLLECTING PERMIT, EACH PERMITHOLDER MUST FURNISH A BOND PAYABLE TO THE COUNTY IN AN AMOUNT EQUAL TO NOT LESS THAN \$500.00 FOR EACH VEHICLE LICENSED, BUT NOT TO EXCEED \$3,000.00 IN TOTAL. WITH SURETY APPROVED BY THE BOARD AND CONDITIONED TO INDEMNIFY AND SAVE HARMLESS THE COUNTY AS WELL AS ANY PERSON FROM ALL EXPENSE OR DAMAGE THAT MAY BE INCURRED BY SUCH, CAUSED BY ANY FAILURE TO COMPLY WITH THE PROVISIONS OF THIS ARTICLE. SUCH BOND SHALL BE DEPOSITED WITH THE TREASURER OF THE COUNTY. THE ORIGINAL BOND SHALL BE FOR A PERIOD OF NOT LESS THAN 12 MONTHS AND SHALL BE RENEWED ANNUALLY. §17-32 (A)</b>
