1. Closed Session:

- a. *Section 2.2-3711(A)(4)* The protection of the privacy of individuals in personal matters not related to public business.
 - i. Provisional ballots from the November 3, 2020 General Election

The Board convened into closed session and discussed the provisional ballots from the November 3, 2020 General Election. There were some that needed signatures, so they were tabled until the Friday, November 6th at 1:00 PM.

The Board came out of closed session and certified the following:
